

## **RECIPROCAL CLUB AGREEMENT**

**Between**

**LONGWOOD CRICKET CLUB**

**And**

**GUAYAQUIL TENIS CLUB**

It is mutually agreed that Guayaquil Tennis Club and Longwood Cricket Club ("Longwood") enter into a Reciprocal Club Agreement under the following terms and conditions:

### **ENTRY TO THE HOST CLUB**

1. Full members of Guayaquil Tennis Club will qualify as Reciprocal Members of Longwood. Full members of Longwood will qualify as Reciprocal Members of Guayaquil Tennis Club. Reciprocal Members will be entitled to those benefits and privileges of membership offered by the Host Club to its own members, subject to the terms and conditions of this Reciprocal Club Agreement.
2. A Reciprocal Member (sometimes herein referred to as a "Guest Member") is bound by the Rules, By-laws and Regulations of the Host Club. Any breach by a Guest Member of the Host Club's Rules, By-Laws, Regulations or terms of the Reciprocal Agreement may result in withdrawal of the right accorded to such Guest Member to use the Host Club.
3. Reciprocal Club privileges are regarded as short-term visiting rights only. A Reciprocal Member may use the Host Club for up to 7 days in any one calendar year and may not be signed in as a guest by another member of the Reciprocal Club.
4. On each occasion before use of the Reciprocal Club, Reciprocal Members must show to the Host Club's Manager a letter of introduction from the Reciprocal Club's Manager dated no more than 4 months prior to the date of admission to the Host Club. The letter of introduction must confirm the Reciprocal Member's current Membership status and domicile.
5. On arrival at the Host Club, Guest Members must register at the front desk and introduce themselves to the Club Manager or fellow manager to receive a greeting and an orientation regarding the Host Club's premises, rules, practices regarding court use, and related matters.
6. All Guest Member accounts must be settled before departure. Please note that Longwood does not accept credit cards.
7. Please note that Longwood requires members and guests to wear predominately white tennis attire. The rule applies to shoes and socks as well as clothing.

**GUESTS**

- 8. A Guest Member may bring up to four guests to the Host Club under the same conditions as Members' guests. Guest Members are wholly responsible for the conduct of their guests.
- 9. Normal guest fees will apply to Guest Members' guests.

**USE OF FACILITIES**

- 10. Guest Members may use all of the Host Club's sports facilities; however, they may not play tennis on more than 7 days in any one calendar year.
- 11. Each Club reserves the right to deny or revoke any particular Guest Member(s)' privileges on such grounds as it sees fit.

**EFFECTIVE DATE**

- 12. This Reciprocal Agreement will be entered into on the date set below and will continue in force until terminated by either Reciprocal Club following a 30-day written, and sent by email or ordinary mail, notice period.
